### A Silver Tsunami hits Carlsbad!

Have you heard of the Silver Tsunami? I hadn't either, until recently. It has become a common expression used to describe the unprecedented increase in the number of older people in the

world. According to AARP, 10,000 people turn 65 every day, and this is just in the United States. By 2050, AARP predicts that older adults will represent 20 percent of the population. That

is quite an ex-

plosion. I'm not sure it is fair to label it a tsunami, but the alliteration sure is fun (technically, a tsunami is a large wave that results in vast destruction and mass casualties – not a very flattering way to label the growth in our aging population). In November 2023 the Centers for Disease Control and Prevention reported that the average life expectancy in 2022 rose by more than a year to 77.5 years. That was up 1.1 years from 2021. We have almost totally recovered to the record-breaking life expectancy ages that we had reached before Covid-19 hit the scene in 2020.

Whether or not these statistics are news to you, they are certainly not news to our 2023 CBAD Community Impact winner – **Senior Care Options**. # Get ready for a year of Main Street fun

Central to everything the **Carlsbad Village Association** (CVA) does is to brand downtown Carlsbad as a premier destination. In doing so, CVA supports the several hundred small busi-



nesses in Carlsbad Village. One key way we showcase our downtown businesses is through unique events. CVA's certified organic farmers market and approximately 30 additional events draw tens of thousands of people downtown each

year. Here are a few of our events that you don't want to miss:

Carlsbad's downtown farmers market is turning 30 this year! From humble beginnings in a parking lot on Roosevelt Street, it has enjoyed a decade being front and center in the heart of Carlsbad Village on State Street. Businesses on State Street and the surrounding area receive a weekly boost with the market's annual attendance of roughly 150,000 people per year with both locals and visitors relying on it week after week. The State Street Farmers Market hosts over 60 independent and family-owned businesses every week starting at 2:30pm with local produce, flowers, seafood, meat, eggs, artisan foods, and international hot food to-go too.

In February CVA celebrates Valentine's Day by packing the Village with a two-day "hunt" for glass blown hearts created by **Barrio Glassworks**, and a double-bus blood drive during Hearts of Carlsbad Village. This is not

only a local's favorite, but it also serves as a tourism campaign with the help of **Visit Carlsbad** and area hotels, drawing a couple thousand people downtown for a weekend of fun.

CVA continues to expand its juried, fine art show, Art in the Village, that has been bringing exceptional local and regional art to the Village for over two decades. In addition to offering 115 art booths, over 20 local musicians fill our downtown streets with music, as close to 10,000 people enjoy this exceptional open-air art experience.

The summer would not be complete without Flicks at the Fountain, a unique event that celebrates community on every level. For five consecutive Thursday nights in July and August, a couple hundred people pack the fountain parking lot at the corner of Grand and State for a night of free movies under the stars. This family-friendly event is a local's favorite that has been going strong for over a decade.

Taste of Carlsbad Village is CVA's signature event that has helped shine a bright spotlight on the incredible dining and beverage scene in downtown Carlsbad. It celebrates everything from its fast casual eateries to its Michelin starred dining. This ticketed event introduces 1,000 foodies to nearly 40 Village restaurants and 15 beverage providers during one epic culinary night. Tickets go on sale around Labor Day weekend and sell out in a matter of hours due to its popularity.

CVA's newest way to celebrate downtown Carlsbad and brand it for lasting impressions is through its Carlsbad Village merchandise. Combining the most beloved elements of our downtown from its iconic street sign to the seven miles of pristine beach, we encourage people to Experience the Village with our t-shirts, long sleeve shirts, sweatshirts, onesies, tote bags, ball caps, license plates, and even dog bandanas. Carlsbad branded merchandise is on sale at the weekly farmers market and at CVA's office at 2695 State Street.

Every Carlsbad Village Association event or activation is designed to help increase the awareness of downtown Carlsbad and showcase its small businesses to keep "Mainstreet" thriving. We are looking forward to a robust year of programming in 2024.

## President touts power of CSUSM in report to the community

In July, **Cal State San Marcos** President Ellen Neufeldt was invited to attend National Summit on Equal Opportunity in Higher



Education, hosted by the U.S. Department of Education. The event convened senior officials the in Biden-Harris Administration and education leaders from across the country to discuss innovative strategies and resources for colleges to expand resources to

higher ed.

Neufeldt attended as a representative of not only CSUSM, but the entire 23-campus California State University, and she was one of only two invited leaders representing regional public universities. As she chatted with other officials throughout the day, she talked about some of the practices that CSUSM is modeling to advance student success.

And she was pleased, but not necessarily surprised, to discover that the university's reputation already was well known in the halls of the Department of Education.

The secret is out. Almost a year after a prominent online publication ranked CSUSM first out of 1,400 schools nationally in the social mobility of its students, the university is increasingly being recognized as a place where students of all backgrounds and income levels thrive, both before and after graduation.

Neufeldt spoke with pride about the subject during her annual Report to the Community address on Sept. 26 on campus before a capacity crowd of about 350 business, education, government and nonprofit leaders from North County and beyond.

"Whether in the halls of D.C., the chambers of Sacramento or right here in our region, I love talking about Cal State San Marcos and our unwavering commitment

to social mobility," Neufeldt said. "Not only as a moral and ethical imperative, but an economic and workforce pipeline necessary for our region, state and nation."

CSUSM this fall welcomed the largest first-year class in its 34-year history, and that group was culled from nearly 20,000 applications, a 50% increase from the previous high in 2018. And all those students evidently are enjoying their time on campus more than ever, as CSUSM recently was ranked 12th in the country for student experience by the Wall Street Journal, based on a methodology that reflects the perceptions of students and alumni related to aspects of student life.

While calling the No. 1 ranking in social mobility a "wonderful surprise," Neufeldt added: "Let me be clear – we don't do it for the accolades. We do it for our students, their families and communities, and the industries that will benefit from the knowledge and skills imparted to our graduates. That's how we define social mobility and, for us, that's what our work together is all about."

#### IN OTHER HIGHLIGHTS FROM THE RE-PORT TO THE COMMUNITY SPEECH:

• CSUSM is in discussions with potential donors for a proposal to introduce new accelerated and dual enrollment pathways so that students as young as high school can take classes toward a degree.

• After a year in which the university added five new district partners to The Alliance, Neufeldt announced a vision to expand the initiative to every school district in the region, including Imperial County, while incorporating living/learning communities to enhance students' success.

• Through the work of the new military roundtable advisory group, CSUSM has partnered with Camp Pendleton to bring academic programs to the base, including cybersecurity, supply chain management and nursing. • Nordson Corporation has become the first industry donor for the future Integrated Science and Engineering Building, which will allow CSUSM to grow its engineering program to nearly 2,000 students, thereby meeting CSU and California workforce goals in STEM.

• The university will break ground this winter on the University Village affordable housing and dining complex, which is being funded in part by \$91 million from the state and will provide space for 550 residents. When that facility is completed in fall 2026, supplemented by a separate housing agreement with North City, CSUSM will be able to increase its total of student residents to almost 3,000.

• CSUSM is in the early stages of planning a recreation and wellness facility – being championed by student leaders – that will offer dynamic recreation through fitness and wellness programming.

• University researchers secured \$25 million in grants during the last fiscal year, surpassing the previous high of \$18 million established five years ago.

• Thermo Fisher Scientific, the biotech giant based near Boston and with a campus in Carlsbad, has endorsed CSUSM as an official partner campus, signaling a formal commitment to enhancing and expanding current collaborations.

CSUSM acknowledged three regional community colleges: **MiraCosta**, Mt. San Jacinto and Palomar as Partners of the Year. All three were recognized for their critical role in reshaping higher education and addressing the evolving needs of students and the region.

Also, the Fran Aleshire Leadership Award went to Bret Schanzenbach, the CEO of the **Carlsbad Chamber of Commerce**, for building strong relationships with and among business and community.



• SB 399 (Wahab; D-Hayward) Bans Employer Speech. Chills employer speech regarding religious and political matters, including unionization. Is likely unconstitutional under the First Amendment and preempted by the National Labor Relations Act. Passed Senate, May

25, 26-7. In Assembly Appropriations Committee, July 11. Failed deadline. CalChamber Opposed/**Job Killer 2023.** 

#### • SB 525 (Durazo; D-Los Angeles) Costly Minimum Wage Increase.

Imposes significant cost on health care facilities and any employer who works with health care facilities by mandating increase in minimum wage to \$25. Job killer tag and opposition removed due to September 11, 2023, amendments, which phased in certain minimum wage increases based on hospital size and operations. Passed Senate, May 31, 21-11. Passed Assembly, Sentember 14, 62, 12. Senate concurred

#### • SB 881 (Alvarado-Gil; D-Jackson)

**Sick Leave Reform.** Significantly improves employers' ability to implement California mandatory paid sick leave and curb attempts to take leave for impermissible purposes. Failed passage in Senate Labor, Public Employment and Retirement, April 19, 1-3-1.

#### LEGAL REFORM • SB 365 (Wiener; D-San Francisco)

**Undermines Arbitration.** Discriminates against use of arbitration agreements by allowing trial courts to continue trial proceedings during any appeal regarding the denial of a motion to compel. Passed Senate, May 24, 30-9. Passed Assembly, September 7, 47-22. Signed—Chapter 710. CalChamber Opposed/Job Killer 2023.

# Keeping your immune system strong as you age

#### TrueCare's Carlsbadbased primary care provider separates myths from the facts

There is no shortage of online and wordof-mouth health advice with promises of alleviating common ailments that come



with getting older. But Jenny Young, a Family Nurse Practitioner at TrueCare Carlsbad Health Center, wants to remind you to check with your provider first, even when taking over-the counter vitamins and supplements. "Many patients

come to me as they navigate the aging process and ask about vitamins and supplements," Young notes. "Some have seen advertisements, or a friend or family member has suggested the latest product to them. But many of these wellness trends interact with other medications."

Young suggests a few tips for keeping your immune system strong without falling for the hype.

"I see a lot of patients who take fish oil with omega-3s, which is good for the heart and brain. It's widely available but also thins the blood. That effect is especially concerning with patients taking pain relief drugs such as ibuprofen (Advil) or naproxen (Aleve)."

Young points out that fish oil can be good for you, if you take the right one. "When I

look at a lot of fish oil products, they have fillers and may not really be helping, especially if they interfere with other medications."

Many people also take baby aspirin for the heart. These are blood thinners too. "The U.S. Task Force advises that low dose aspirin should only be taken by direction of your health care provider," she says.

Iron supplements are also popular for battling low energy, but Young warns iron can be toxic as it builds up in the liver. "If you are not anemic, you probably don't need extra iron."

Young suggests looking for vitamins specifically made for people who are 50 years and older, especially menopausal women. Many of these don't add extra iron, making them a better choice.

"And if you take supplements with coffee,

know that caffeine hinders the absorption of nutrients. Be sure to take vitamins and supplements with water and wait at least one hour after having coffee.... And Vitamin D needs to be taken with a good fat like nuts or avocado."

Other popular immunity supplements are zinc and Vitamin C. "Many older adults are low in zinc, making them susceptible to infection, so a supplement can be helpful. And Vitamin C does help keep the immune system strong. First, get the green light from your provider for the best dosage for you before spending money on various products."

The most reliable way to protect your immunity is to wash your hands regularly and get your recommended vaccines. "Seniors should ask about getting a high dose flu

shot if they are 65 years and older. This offers 3-4 times the immunity protection as a regular flu shot. Additionally, the Respiratory Syncytial Virus (RSV) vaccine is available without a prescription for seniors age 60 and older. It protects against a common respiratory virus and is covered by Medicare and Medi-Cal."

There also are several pneumonia vaccines. "Which one you get depends on your medical history. Your provider can provide guidance."

Lastly, the shingles vaccine has a bad reputation due to side effects like fatigue or itchy rash at the injection site. However, these side effects are short lived. Getting shingles is much more serious and can leave you with lifelong conditions, such as skin and nerve pain. "If you are 50 years or older, ask your provider about getting the shingles vaccine."

Young concludes that exercise and a healthy diet remain important factors for keeping immune systems strong. "The Mediterranean diet is great for seniors and has immune boosting benefits. Combined with regular exercise, this helps build overall health and immunity."

If the market is temporarily down, it doesn't mean you need to sell investments to "cut your losses" — especially if these investments still have good fundamentals and are still appropriate for your portfolio.




